



### **Christmas in October 2017: Rules and Regulations**

VPI Home Solutions is not responsible for any illegible, misplaced, incomplete forms, damaged or late entries. The address listed on each entry form must be the address where the prize is to be installed if such entry is selected as a winner. If entry is on web, contest rules box must be checked. If entry is at event or our showroom, contest rules box must be checked. A copy of contest rules will be at each event and at our showroom.
